## STAFF ANALYSIS ITEM—1

Department of Motor Vehicles Delano Field Office Replacement Kern County

#### **Action Request**

If approved, the requested action would authorize an augmentation contingent upon expiration of the 20-day legislative notification.

### Scope Description

**This project is within scope.** The scope of this project includes the design and construction of a new 12,371 square foot new single-story Department of Motor Vehicles (DMV) Field Office on a 3-acre site in the city of Delano. The project will provide nine customer transaction terminals and will include a motorcycle test area, drive-test canopy, solar canopies for parking areas and electric vehicle charging stations.

### Funding and Cost Verification

This project is not within cost. Total project funding includes \$1,229,000 in Motor Vehicle Account (MVA) for acquisition provided in the 2015 Budget Act (\$1,022,000), and a subsequent augmentation in May 2018 (\$207,000). The 2016 Budget Act provided \$1,483,000 MVA for the preliminary plan (\$688,000) and working drawing (\$795,000) phases of the project. The 2021 Budget Act provided \$16,982,000 General Fund for construction, of which \$9,846,000 was reverted by the 2023 Budget Act due to the original contractor being terminated for convenience by the State. Of the amount retained, \$6,725,000 was used to cover expenses incurred on the original contract, and \$411,000 was used for the new contract. The 2023 Budget Act also provided \$17,314,000 Public Buildings Construction Fund for the construction phase and a subsequent augmentation of \$1,614,000 in May 2025. In total, authority from Budget Acts total \$26,955,000, prior augmentations total \$1,821,000, and when combined with the new request of \$2,175,000, if approved, the new total authorized project costs would be \$30,951,000.

The requested augmentation of \$2,175,000 is driven by the need to redesign the fire sprinkler system. The fire sprinkler system requires web steel trusses which were ordered early in the project to best ensure supply chain issues wouldn't affect the project schedule. However, the trusses were not engineered to accommodate the weight of the fire sprinkler system. This resulted in a major redesign of the fire sprinkler system so it could be supported by the trusses and required the project to stop construction activities until State Fire Marshal approval could be obtained. The requested augmentation of \$2,175,000 includes approximately \$400,000 to design and gain approval of the new fire sprinkler system, \$1,375,000 associated with project delays and maintaining an active construction site, and \$400,000 to restore project contingency.

On November 25, 2025, the Department of Finance notified the Chairs of the Joint Legislative Budget and fiscal committees in each house of its intent to approve the augmentation and recommend that the Board approve this action no sooner than 20 days from that date.

The Department of General Services, on behalf of Department of Motor Vehicles, completed a Summary of Conditions Letter for the project on January 30, 2018, and no issues that would adversely affect the beneficial use and quiet enjoyment of the project were identified.

## STAFF ANALYSIS ITEM—1

High-Speed Rail Authority Merced to Bakersfield Segment Various Counties

### Action Requested

Adopt a Resolutions of Necessity authorizing the use of eminent domain by the High-Speed Rail Authority to acquire properties or interests in properties for the High-Speed Train System.

Note: Property 2, for Bakersfield Properties, has been pulled and no Resolution of Necessity for this property will be considered at today's meeting.

#### Background

Under California Eminent Domain Law, the Board is the governing body of the High-Speed Rail Authority (Authority) for purposes of adopting Resolutions of Necessity that are required for the Authority to initiate eminent domain proceedings. To adopt a Resolution of Necessity the Board must consider that the following conditions have been met:

- (A) The public interest and necessity require the project;
- (B) The project is planned or located in the manner that will be most compatible with the greatest public good and the least private injury;
- (C) The property sought to be acquired is necessary for the project; and,
- (D) The offer required by Government Code section 7267.2 has been made to the owner or owners of record or the offer has not been made because the owner cannot be located with reasonable diligence.

The properties are within the right of way for the 171-mile Merced to Bakersfield Segment and are within the preferred alignment as previously approved by both the High-Speed Rail Authority Board of Directors and the Federal Railroad Administration. Acquisition of this property will allow the Authority to move forward with construction of the High-Speed Train System (HSTS).

The Authority notified the Board's staff that in June, 2025, the respective property owners were provided with a first written offer to purchase the subject properties, as required by Government Code section 7267.2. The Authority has informed the Board's

staff that negotiations to acquire the properties are continuing; however, to keep the project on schedule, the adoption of Resolutions of Necessity to authorize the use of eminent domain are required at this time.

On November 19, 2025, and November 20, 2025, Notices of Intent to adopt a Resolution of Necessity was mailed by Board staff to the owners. These notices were sent in accordance with Code of Civil Procedure section 1245.235.

## STAFF ANALYSIS ITEM—1

#### Action Requested

If approved, the requested action will adopt a resolution authorizing the delegation of certain functions and approvals to Board staff.

#### Background

The Board is authorized pursuant to Government Code section 15770.2 to delegate any of its powers and duties it deems proper to staff. The Board has previously taken action to delegate a scope of powers and duties to the Executive Director and to Deputy Directors in May 2018 and December 2019. The May 2018 resolution delegates certain powers and duties related to the Board's involvement with the construction, development, and financing of correctional facilities. The Board's December 2019 resolution delegates certain powers and duties related to the Board's involvement in a variety of capital outlay matters, including actions necessary prior to the issuance of its lease revenue bonds. The resolution being considered today not only consolidates the two delegation resolutions but updates certain duties and powers to better align with current practices and needs.

The delegations involve entering into a variety of different types of contracts and approving a variety of required actions related to property acquisition or construction of state public works projects, with each delegation containing certain restrictions or conditions on the scope of the delegation. The resolution also increases the number and types of delegations that must be reported back to the Board. Specifically, the list of delegated actions includes, but is not exclusive of, entering contracts under \$300,000 (such as outside counsel contracts), finalizing and entering into project delivery agreements, leases, property rights (easements/right of way), approving site selection requests, augmentations, scope/cost/schedules, preliminary plans, performance criteria, reversion of project savings, consent to permitted encumbrances or other arrangements impacting bond encumbered property, prepare and submit Written Requests, and authorize the preparation of bid proposals for lease-revenue funded projects. The delegation of powers or duties does not apply if any of the items have controversial or unique policy concerns.

Staff Recommendation: Adopt resolution.
