Judicial Council of California New Modesto Courthouse Stanislaus County

#### Action Requested

If approved, the requested action would adopt an amended resolution authorizing actions to be taken to provide for interim financing, authorize the sale of lease revenue bonds, and other related actions.

In October 2019, the Board adopted a resolution authorizing actions to be taken to provide for interim financing in an amount not to exceed \$237,243,000, authorize the sale of lease revenue bonds, and other related actions (2019 Resolution). After adoption of the 2019 Resolution, supplemental appropriations of \$13,243,000, \$52,759,000, and \$6,554,000 were included in the 2020, 2021, and 2022 Budget Acts,

respectively, for the project. This amended resolution will among other things, amend and restate the 2019 Resolution in its entirety, increasing the interim financing authority to a maximum amount of \$309,799,000 to account for the supplemental appropriations included in the 2020, 2021, and 2022 Budget Acts.

#### Scope Description

**This project is within scope.** The authorized project is a new, approximately 27-courtroom courthouse, with one unfinished courtroom, and approximately 309,000 square feet in the City of Modesto. The project will consolidate court operations from six existing court facilities and will relieve the current space shortfall, increase security, and replace inadequate and obsolete facilities in Stanislaus County.

#### Funding and Cost Verification

**This project is within cost.** Government Code Sections 70371.5 and 70371.7 appropriated \$14,766,000 for acquisition, the 2014 Budget Act appropriated \$11,026,000 for preliminary plans, the 2018 Budget Act appropriated \$15,252,000 for working drawings, and construction appropriations totaling \$311,865,000 include \$2,066,000 from the 2016 Budget Act, \$237,243,000 from the 2018 Budget Act, \$13,243,000 from the 2020 Budget Act, \$52,759,000 from the 2021 Budget Act, and \$6,554,000 from the 2022 Budget Act.

Board of State and Community Corrections Adult Local Criminal Justice Facilities Project Napa County

#### Action Requested

If approved, the requested action would adopt a resolution authorizing actions to be taken to provide for interim financing, authorize the sale of lease revenue bonds, and other related actions.

#### Scope Description

**This project is within scope.** The project scope for SB 844 funding includes the design and construction of approximately 50 rated beds and an approximately 30-bed medical/mental health unit along with programming space, kitchen, laundry, central control, in-person visiting, intake, sallyport, and an administrative building.

The project will include, but is not limited to, electrical; plumbing; mechanical; heating, ventilation, and air conditioning; security; area of refuge and pathways; fire protection systems; and all other necessary appurtenances.

#### Funding and Cost Verification

This project is within cost. Section 15820.94 of the Government Code (SB 844) appropriated \$244,516,000 lease revenue bond financing authority to partially finance the design and construction of adult local criminal justice facilities. Award of this funding to individual counties was administered through the Board of State and Community Corrections (BSCC) through a competitive public process. The BSCC has conditionally awarded \$20,000,000 from this appropriation to Napa County for this project. All acquisition, study, any design, and construction costs in addition to this

award amount will be paid by the county. At the time of establishment, the total estimated project cost was \$60,057,000. Subsequent to this action, a new project estimate was prepared in association with the award of the construction contract and recognize revised project costs were approved on November 22, 2022 by the Board. Based on this new revised estimate, the current total estimated project cost is \$71,534,000.

Board of State and Community Corrections Adult Local Criminal Justice Facilities Project Napa County

#### Action Requested

If approved, the requested action would adopt a resolution authorizing actions to be taken to provide for interim financing, authorize the sale of lease revenue bonds, and other related actions.

#### Scope Description

**This project is within scope.** The project scope for SB 863 funding includes the design and construction of approximately 260 rated beds within eight medium/maximum security housing units. Each housing unit contains approximately 30 beds. Each housing unit pod will have a day room, interview room, an exam room, and an outdoor recreation yard.

The project will include, but is not limited to, electrical; plumbing; mechanical; heating, ventilation, and air conditioning; security; area of refuge and pathways; fire protection systems; and all other necessary appurtenances.

#### Funding and Cost Verification

This project is within cost. Section 15820.932 of the Government Code (SB 863) appropriated \$420,000,000. Award of this funding to individual counties is administered through the Board of State and Community Corrections (BSCC) through a competitive public process. Initially the BSCC conditionally awarded \$2,821,000 from the SB 863 appropriation to Napa County for this project. On March 2, 2018, the Board established the scope, cost, and schedule of the Napa County Adult Local Criminal Justice Facility Project officially allocating \$2,821,000 from SB 863 for design and construction of the

project. At the time of establishment, the total estimated project cost was \$21,963,000. A revised project cost estimate was prepared in association with a scope change. The new estimated project cost of the project was \$48,094,000. Subsequent to that action, a new project estimate was prepared in association with the award of the construction contract and recognize revised project costs for \$48,341,000 were approved on November 23, 2022 by the Board.

#### Action Requested

If approved, the requested action would adopt a resolution to approve the form of agreements to terminate agreements, recognize the termination of agreements related to the construction and financing of the Project, and authorize other actions related to the termination of the agreements.

#### Background

Section 15820.913 of the Government Code (AB 900) appropriated \$740,445,397 lease revenue bond financing authority to partially finance the design and construction of local jail facilities. Award of this funding to individual counties is administered by the Board of State and Community Corrections (BSCC). BSCC conditionally awarded \$80,000,000 from this appropriation to Monterey County (County) for the construction of a local jail facility (Project) to be located at 1410 Natividad Road, Salinas, CA 93906.

On October 31, 2014, the Board, BSCC, and the County entered into a Project Delivery and Construction Agreement (PDCA) related to the method of delivery of the Project,

the construction of the Project, and the financing of the Project. On March 14, 2017, BSCC and the County entered into a ground lease, easement agreement, and right of entry agreement. On June 9, 2017, the Board adopted a resolution authorizing actions to be taken to provide for interim financing, authorize the sale of lease revenue bonds, and other related actions (Interim Financing Resolution).

Due to significant delays in the construction completion schedule, this project would likely have required the issuance of taxable bonds, which would significantly increase the cost of financing. As part of the 2022 Budget Act, General Fund dollars were appropriated to eliminate the need to issue costlier bonds, resulting in debt service cost avoidance of approximately \$45 million over the 15-year life of the bonds.

The 2022 Budget Act appropriated \$82,949,000 to pay off the Pooled Money Investment Account loan for the Project. This allocation reimbursed the following costs related to the interim loan: \$80,000,000 in project costs, \$2,898,000 in interest, and \$51,000 for related administrative fees.

Pursuant to their terms, the PDCA and right of entry terminate upon completion of the Project. The Project was completed on September 14, 2022.

Because bond proceeds were not utilized to fund the Project, the proposed resolution would, among other things, authorize actions to recognize the termination of the PDCA and the right of entry, and to terminate the ground lease and easement agreement that were entered into to facilitate the financing and construction of the Project.

#### Action Requested

Adopt Resolutions of Necessity authorizing the use of eminent domain by the High Speed Rail Authority to acquire properties or interests in property for the High Speed Train System.

#### Background

Under California Eminent Domain Law, the Board is the governing body of the High Speed Rail Authority (Authority) for purposes of adopting Resolutions of Necessity that are required for the Authority to initiate eminent domain proceedings. To adopt a Resolution of Necessity the Board must consider that the following conditions have been met:

- (A) The public interest and necessity require the project;
- (B) The project is planned or located in the manner that will be most compatible with the greatest public good and the least private injury;
- (C) The property sought to be acquired is necessary for the project; and,

(D) The offer required by Government Code section 7267.2 has been made to the owner or owners of record or the offer has not been made because the owner cannot be located with reasonable diligence.

The properties are within the right of way for the Central Valley Segment, extending from Madera to Shafter, and are within the preferred alignment as previously approved by both the High Speed Rail Authority Board of Directors and the Federal Railroad Administration. Acquisition of these properties will allow the Authority to move forward with construction of the High Speed Train System (HSTS).

The Authority notified the Board's staff that for Properties 1 through 9, between August 2022 and September 2022, the respective property owners were provided with a first written offer to purchase the subject property, as required by Government Code section 7267.2. The Authority has informed the Board's staff that negotiations to acquire the property are continuing; however, to keep the project on schedule, the adoption of Resolutions of Necessity to authorize the use of eminent domain is required at this time.
