- Approve and direct the Executive Director and Deputy Directors to execute and deliver any documents as required to redeem a portion of the outstanding Series 2009G-2 Bonds and defease and redeem a portion of the outstanding Series 2017B Bonds, which bonds financed and refinanced certain costs of the Deuel Vocational Institution New Wastewater Treatment Plant.
- 2) Approve the form of Escrow Agreement, by and between the Board and the State Treasurer.
- 3) Approve the form of Termination Agreement, by and between the Board and the Department.

## STAFF ANALYSIS—1

California Department of Corrections and Rehabilitation Deuel Vocational Institution, New Wastewater Treatment Plant Project San Joaquin County

Action Requested

If approved, the request action would approve adoption of a resolution to approve and direct the Executive Director and Deputy Directors to execute and deliver any documents as required to redeem a portion of the outstanding Series 2009G-2 Bonds and defease and redeem a portion of the outstanding Series 2017B Bonds, which bonds financed and refinanced certain costs of the Deuel Vocational Institution New Wastewater Treatment Plant; approve the form of Escrow Agreement, by and between the Board and the State Treasurer; and approve the form of Termination Agreement, by and between the Board and the Department.

#### **Background**

Deuel Vocational Institution (DVI) was a state prison established in 1953 located in the city of Tracy in San Joaquin County. The DVI campus contains 104 buildings and was designed to house 1,681 incarcerated individuals. DVI is the sixth oldest prison in California Department of Corrections and Rehabilitation facility portfolio and provides for approximately 2% of its overall design capacity.

DVI's primary mission was to act as a Reception Center (RC) that received incarcerated individuals from 29 Northern California counties. Staff processed the RC incarcerated population by compiling and evaluating the incarcerated individuals' criminal records, life histories, medical and physiological histories, and social histories. The information was used to determine the incarcerated individuals' custody score and to identify any specific placement needs the incarcerated individuals may have. Once the reception process was completed, the inmates were transferred to one of the 34 state prisons where they served the remainder of their prison sentence.

DVI's secondary mission was to provide housing for general population Level I, II, and III incarcerated population serving their terms of incarceration. The general population incarcerated individuals at DVI provided support to the institution by working in maintenance, food service, janitorial, as well as other jobs that serve in supporting the operation of the prison.

It was previously determined that DVI would close as part of a larger prison closure plan. As a result, the last incarcerated individuals left DVI in July 2021 and the prison was deactivated on September 30, 2021. The prison is currently in warm shut down and this property is being considered for addition to the state's surplus property list, which will allow it to be utilized for affordable housing projects pursuant to Executive Order 06-19, repurposed for other state or local uses, or sold on the open market.

## **STAFF ANALYSIS ITEM-1**

Department of Education, State Special Schools Fremont: Perimeter Security Fence Alameda County

Action Requested

If approved, the requested action will approve preliminary plans and an augmentation contingent upon expiration of the 20-day legislative notification.

#### Scope Description

**This project is within scope.** The project includes the installation of a new 8,800 linearfoot, steel perimeter security fence, along with vehicle and pedestrian gates, at the State Special School – Fremont campus, which includes the School for the Deaf, School for the Blind, and Diagnostic Center of Northern California.

#### Funding and Cost Verification

**This project is not within cost.** The 2021 Budget Act provided \$747,000 General Fund (GF) for the design phases of this project, whereas construction authority was reverted. Originally the project consisted of a 6,600 linear foot fence around three sides of the campus. However, during the design phase it was concluded that the chain link fence between the railroad and school property also needed replacement, resulting in the need for an additional 2,200 linear feet of fencing. This additional scope was reflected in the 2023 proposal to reappropriate.

Updated cost estimates were provided upon completion of preliminary plans for the full 8,800 linear foot project, reflecting a need to augment working drawings by \$149,000 (19.9 percent of appropriated funds) and an overall project deficit of \$2,515,000 General Fund (33.3 percent), as estimated total project costs changed from \$7,548,000 to \$10,063,000. Funding for the construction phase is anticipated in a future Budget Act.

On July 25, 2023, the Department of Finance notified the chairs of the Joint Legislative Budget Committee and fiscal committees in each house of its intent to recommend the Board approve preliminary plans with estimated total costs in excess of 20 percent of the amount recognized by the Legislature no sooner than 20 days from that date.
