DEPARTMENT OF GENERAL SERVICES (7760) 2024 SERIES A (TAX EXEMPT) AND B (TAXABLE), LEASE REVENUE BONDS SACRAMENTO REGION: NEW RICHARDS BOULEVARD OFFICE COMPLEX, ALSO KNOWN AS THE MAY LEE STATE OFFICE COMPLEX

- Project: Sacramento Region: New Richards Boulevard Office Complex, also known as the May Lee State Office Complex

- 1) Authorize the sale of the State Public Works Board lease revenue bonds to finance and refinance costs related to the Sacramento Region: New Richards Boulevard Office Complex, also known as the May Lee State Office Complex for the Department of General Services.
- 2) Approve the form of various documents related to and approve and authorize other related actions in connection with, the authorization, issuance, sale, and delivery of said lease revenue bonds.

STAFF ANALYSIS ITEM—1

Department Of General Services (7760) 2024 Series A (Tax Exempt) And B (Taxable), Lease Revenue Bonds Sacramento Region: New Richards Boulevard Office Complex, also known as the May Lee State Office Complex

Action Requested

If approved, the requested action would authorize the sale of the 2024 Series A and B lease revenue bonds and approve the form of various documents related to and approve and authorize other related actions in connection with, the issuance, sale, and delivery of said revenue bonds.

<u>Background</u>

The Budget Act of 2019 authorized the Board to issue bonds to fund the design-build phase of the Department of General Services, Sacramento Region: New Richards Boulevard Office Complex, also known as the May Lee State Office Complex.

Concurrent with the issuance of the bonds, the department will enter into a site lease with the Board for the project, under which the Board will lease the site at which the project is

located from the department. The Board will lease the respective facility to the department. The rental payments under these facility lease secure the payment of the principal and interest on the Board's bonds. The lease is scheduled to terminate in 25 years.

The 2024 Series A bonds will be sold as tax exempt, and the Series B bonds will be sold as taxable, through a negotiated sale as described in the Purchase Contract. The estimated total project costs to be financed are \$1,002,813,000, and the estimated "Not to Exceed" par amount of the 2024 Series A bonds is \$886,370,000, and the estimated "Not to Exceed" par amount of the 2024 Series B bonds is \$267,890,000.

Project

The 2024 Series A and B bonds will finance the Sacramento Region: New Richards Boulevard Office Complex, also known as the May Lee State Office Complex, which includes a new office campus on state property at the corner of Richards Boulevard and North Seventh Street in the City of Sacramento. The office complex consists of four, 7-story to 11-story office buildings with a multi-floor podium as the base for the buildings, a 7-level parking garage with 1,020 spaces and an additional surface parking lot with 400 spaces. The project also includes space for a cafeteria, auditorium, retail, café, training center and childcare. The complex will be Zero Net Energy, Zero Net Carbon and achieve a LEED Gold certification. Construction is expected to be completed by April 2024. Tenants will include the California Department of Tax and Fee Administration, the Department of Housing and Community Development, the Civil Rights Department, the Commission on Teacher Credentialing, the Department of Financial Protection and Innovation, the Department of Real Estate, and the Department of Health Care Access and Information.
